The roundtable provided an opportunity for multi-stakeholder dialogue from both Asia and Europe and provided useful inputs to relevant policy processes in the domain of biodiversity and ecosystem services. While in Tokyo, meetings were held with senior staff at the Ministries of Environment and Foreign Affairs to discuss: preparations for the International Year of Biodiversity, UNGA high level meeting on biodiversity in 2010, the Green Wave initiative and the Biodiversity meetings in Nagoya in 2010, among other issues.

### CAPACITY DEVELOPMENT WORKSHOP FOR EUROPE ON NBSAPS AND THE MAINSTREAMING OF BIODIVERSITY

The Second European Workshop on NBSAPs and Mainstreaming of Biodiversity was held from 12 to 16 June 2009 in the Isle of Vilm, Germany, with the generous support of the German Federal Agency for Nature Conservation and the International Academy for Nature Conservation of Germany. A total of 25 participants attended the workshop. The workshop provided an opportunity for countries to exchange experiences and lessons learned in the development, implementation and updating of NBSAPs and mainstreaming of biodiversity into relevant sectors and broader strategies. The workshop introduced and discussed about important tools and concepts in this regard, such as strategic environmental assessment, the resilience thinking and the ecosystem services. The workshop also introduced the guidelines and relevant tools for preparation of the fourth national report, and a few countries shared their experiences in this regard, including use of indicators for reporting. In conclusion, while looking at ways forward, participants shared their thoughts for planned activities including celebration of the International Year of Biodiversity in 2010. All the participants considered this workshop very successful.

### CENSUS OF MARINE LIFE AND CBD COOPERATION



The Secretariat signed a Memorandum of Coopetration with the Census of Marine Life (CoML). The objective of the agreement is to establish a framework of collaboration between the CoML and the CBD Secretariat, with a view to further common goals, including promoting and facilitating capacity building in taxonomy and related technical and scientific cooperation and technology development to provide marine biodiversity observation information into the relevant process of the Convention. Areas of cooperation identified, as per agreement,

include: scientific and technical cooperation related to the Global Taxonomy Initiative, programme of work on marine and coastal biological diversity, the GBO-3 and the Strategic Plan of the Convention, which will be revised at COP-10, as well as other areas of mutual interest. The world's first comprehensive Census of Marine Life - past, present, and future - will be released in 2010.

## MEETING OF THE GROUP OF TECHNICAL AND LEGAL EXPERTS ON TRADITIONAL KNOWLEDGE ASSOCIATED WITH GENETIC RESOURCES

The meeting of legal and technical experts on traditional knowledge was convened in accordance with decision IX/12 of the Conference of the Parties on access and benefit-sharing. The meeting was opened by the Chief Minister of the State of Andhra Pradesh of India,

Dr. Y.S. Rajasekhara Reddy, and the Minister of Environment and Forests of India, Dr. Shri Jairam Ramesh. The purpose of the meeting was to provide legal and technical advice to the Ad Hoc Open-ended Working Group on Access and Benefit-sharing on the issue of traditional knowledge associated with genetic resources, with a view to assisting the negotiations of the International Regime on Access and Benefit-sharing. Indigenous and government nominated experts from around the world had cordial and constructive exchanges of views throughout the four days of deliberations on the specific questions posed to the experts by the Conference of the Parties. The final report includes some concrete advice and recommendations on how to address tradi-

tional knowledge associate with genetic resources in the International Regime. It should greatly facilitate the negotiations on this important issue at the next meeting of the Working Group mandated to negotiate the International Regime, in November 2009. The meeting provided an opportunity for the Ministry to present the **fourth national report of India** to the Secretariat.

## ONLINE FORUM ON STANDARDS FOR LMO SHIPMENTS (PARAGRAPH 3 OF ARTICLE 18 OF THE CARTAGENA PROTOCOL ON BIOSAFETY) - 18 MAY TO 5 JUNE 2009

In its decision BS-IV/10, the Conference of the Parties serving as the meeting of the Parties to the Biosafety Protocol (COP-MOP) requested the CBD Executive Secretary to organize an online conference on paragraph 3 of Article 18. To this end, the Secretariat held the Online Forum on Standards for LMO Shipments from 18 May to 5 June 2009, which aimed to: (i) identify the relevant standards with regard to handling, transport, packaging and identification of living modified organisms; (ii) identify where gaps exist; and (iii) suggest possible modalities to fill the gaps. The Online Forum consisted of four discussion groups organized around guiding questions and also included an 'ask an expert' component whereby experts from different international organizations that work in areas related to standards for the handling, transport, packaging and identification of living modified organisms were available online to answer questions from participants. The following organizations were represented by experts: the Codex Alimentarius Commission, the International Plant Protection Convention, the Organisation for Economic Co-operation and Development, the United Nations Economic Commission for Europe, the World Trade Organization, the World Customs Organization and the World Organisation for Animal Health.

A total of **81 individuals** registered for the Online Forum and more than 100 messages were posted to the Forum. A summary of the outcome of the Online Forum, reflecting the full range of views expressed, will be submitted to COP-MOP 5 for its consideration.

## THIRD SESSION OF THE GOVERNING BODY OF THE INTERNATIONAL TREATY ON PLANT GENETIC RESOURCES FOR FOOD AND AGRICULTURE

A representative of the Secretariat attended the Third session of the Governing Body (GB-3) of the International Treaty on Plant Genetic Resources for Food and Agriculture (ITPGRFA), held in Tunis, Tunisia from 1 to 5 June 2009 and provided the participants of the meeting with an update on the ongoing negotiations on access and benefit-sharing, as well as recent developments related to the Global Strategy of for Plant Conservation. The meeting was attended by approximately 350 participants: Contracting Parties, as well as

representatives from other governments, international organizations, NGOs, farmer organizations and industry, which were invited as observers. During the five days of the meeting, Parties had to address a heavy agenda and dealt with important issues, such as the implementation of the Treaty's Funding Strategy, Compliance, as well as the implementation of the Multilateral System and Article 6 (Farmers' Rights).

## IBD 2010 THEME: "BIODIVERSITY FOR DEVELOPMENT AND POVER TY ALLEVIATION"

Through its Notification issued on 29 May 2009, the Secretariat of the Convention has announced that the theme for the International Day for Biological Diversity (IBD) in 2010 will be "Biodiversity for Development and Poverty Alleviation". It should be noted that next year's IBD will be celebrated during the International Year of Biodiversity. Branding and information materials for International Year of Biodiversity 2010 and the International Day for Biological Diversity 2010 will begin to be released starting in July 2009.

# COOPERATION ON HEALTH AND BIODIVERSITY (COHAB) INITIATIVE SECRETARIAT AGREEMENT: BIODIVERSITY FOR DEVELOPMENT TOOLKIT FOR THE HEALTH SECTOR



An agreement was signed between the **COHAB Initiative Secretariat** and the Secretariat of the Convention on Biologi-

cal Diversity for the preparation of the health element of the Biodiversity for Development Toolkit series. The purpose of the health toolkit is to assist the conservation of biodiversity and facilitate co-operation on biodiversity and development issues through "compiling good practices that support biodiversity conservation and poverty alleviation in a number of different development sectors", and also provide "practical guidance for governments, development agencies, businesses, and non-governmental organizations working to ensure that biodiversity conservation and poverty reduction goals go hand in hand".

Inputs to the toolkit from scientists, practitioners and experts in the areas of health, environment, biodiversity, development and risk management are welcomed, in particular, on case studies on the themes of medicinal resources, disaster risk reduction, emerging diseases, non-communicable diseases, and nutrition / dietary health. 
